Before to the event

- 2. Send the list of products you are interested in.

- 4. Once your application is submitted, proceed to register your Company's information in the Business Platform:
 - A representative from ProMéxico will get in touch to share with you the business (web) platform link to register your contact information, and to provide detailed information on at least 3 products you have shown interest.











- Following the registration, you will receive instructions to build up your business agenda. If you require additional support along this process, please do not hesitate in contacting your ProMéxico representative.
- 5. Send air-tickets purchase confirmation to your ProMéxico representative no later than 30th of August.
- 6. Deadline to get special rates at Quinta Real Hotel is 17 th of August.
